#### **Eligibility Criteria for Admissions to III as per NEP 2020 under FYUGP and V Semester (CBCS).**

- 50% credits passed in the 1st semester. Students must have successfully completed and passed at least 50% of the credits offered in the 1st semester of their respective program.
- 75% internal assessments passed in the 2nd semester: Students must have cleared a minimum of 75% of the internal assessments conducted during the 2nd semester of their program.
